SAMPLE NOMINATION #1

Nominee – Joe Smith

Contribution: Please describe the level of engagement that the nominee has performed in the campus community from July 1, 2022, through June 30, 2023.

Joe Smith has revolutionized the Department. He has brought together faculty and staff from across campus to enhance our student experiences, deepen our community relationships, and improve outcomes in community engagement and service. Joe is also a member of the Staff Senate and is an integral part of the ABC Committee.

Services/Performance: Please give a brief description of the nominees' normal job duties and an explanation of how the nominee exceeded these expectations from July 1, 2022, through June 30, 2023.

Joe is responsible for coordinating the 2,000+ student schedules, which are extremely complicated. He goes above and beyond going through each individual schedule to ensure the student's academic needs are met and to accommodate their other competing commitments such as sports, work, and family responsibilities. He has a kind way with the students, working with them to support them in every way possible, is an openminded facilitator and always asks for feedback to make updates. He worked diligently to balance all the new challenges from COVID-19 and presented out-of-the-box ideas. Continuously collaborates with other departments to ensure that all of our systems are as effective as possible. Joe continues to impress me on a daily basis!

This is another area where Joe is exceptionally impressive! He recruits facilitators from across campus. Staff, faculty, and even graduate students to facilitate. SAMPLE NOMINATION #2

Nominee: Jane Doe

Impact: Please recount the nominee's influence on individuals, the functioning of a unit or program, or the college as a whole from July 1, 2022, through June 30, 2023.

Jane Doe has not only made a significant impact on her School but across campus and has furthered the excellent reputation of TCNJ through regional professional engagement.

For her School, Jane has done tremendous work this past year furthering the 1234 program, revising orientation materials, and, improving advising practices. The 1234 program includes over 300 students and over 50 volunteers. The ever-growing number of volunteers for this program is no doubt to catch Jane's infectious enthusiasm for the culture surrounding this program.

Across campus, her work on the ABCD Team and XYZ Task Force has made an impact across all academic schools. Jane thoughtfully adds her insight and ideas, along with years of advising experience, to be in on conversations that, in turn, produce suggestions that impact the entire campus.

Regionally, Jane presented at the National Conference on X with not one but three remarkable sessions. These programs exemplify that Jane not only focuses on student development but also on giving back to colleagues and thriving despite the challenges posed in Higher Education today.

Dedication: Please describe the nominee's dedication to their department, division, or College as a whole from July 1, 2022, through June 30, 2023.

Jane's dedication is evidenced through all of the care and thought she brings to every conversation and engagement. She stays informed in her field through her regional engagement, as well as her own research, which brings scholarly work to strengthen her knowledge, and is a valuable resource to the School and beyond. The extra time she gives to presentations is also further evidence of her dedication.
